405. BT CONSULTATION – PROPOSED REMOVAL OF THREE TELEPHONE BOXES IN GODALMING

Waverley Borough Council has informed town and parish clerks that BT has opened a consultation about the proposed removal of 46 payphones in the borough. BT would like to remove the payphones on the grounds that they are used infrequently and are expensive to maintain. A table of the affected payphones which gives the postcode, number of calls received in the last year and the relevant ward is attached for the information of Members. The three boxes in Godalming have been highlighted and are located at Deanery Road, Spring Grove and Bargate Rise (Aarons Hill). Photographs of all three are also attached for the information of Members. Notices have been placed in the affected payphones.

Councillors noted that they could see no benefit in retaining the phones or meaningful alternative use and therefore agreed to the removal of the payphones in question.
