### 7. <u>TEMPORARY PROHIBITION OF TRAFFIC ORDER 2017 - OCKFORD ROAD (A3100),</u> <u>GODALMING</u>

SURREY COUNTY COUNCIL PROPOSE TO MAKE the above mentioned Temporary Order under Section 14(1) of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit vehicles from entering or proceeding in that length of Ockford Road (A3100), Godalming that extends from its junction with Holloway Hill (D169), to the eastern side of the roundabout at its junction with Shackstead Lane (D5404). This Temporary Traffic Order is required to enable MDM Services (Cardiff) Ltd. to safely utilise a crane to replace petrol storage tanks and garage canopy. These works are anticipated to be carried out at night between the hours of 20.00 - 05.00, within two nights of the twelve month period of operation of this Temporary Traffic Order that commences on 13th March 2017.

Advanced warning signs will be displayed and the temporary closure will only operate when the relevant traffic signs are displayed. Access for pedestrians will be maintained at all times; cyclists and equestrians will be required to follow the vehicular diversion route or dismount and follow the pedestrian walkway. Due to the positioning of the crane in the highway, it will not be possible to maintain any access for motor vehicles through this temporary closure however access will be maintained at all times to residences, businesses on affected length of Ockford Road, including for emergency vehicles via the diversion for local traffic which will be Shackstead Lane, Tuesley Lane, Park Road, The Drive, Brighton Road and Flambard Way. HGVs and through traffic will be diverted via New Pond Road, The Street, Guildford and Godalming By-Pass, and Portsmouth Road (traffic management plans to be tabled for the information of Members).

#### 8. <u>NOTIFICATION OF SURFACE DRESSING PATCHING WORKS – GREEN LANE,</u> <u>FARNCOMBE</u>

Surrey County Council Highways have notified Godalming Town Council that surface dressing patching work on Green Lane, Farncombe is due to carried out; the work is scheduled to start on 22 March 2017. Surrey County Council Highways have advised that sometimes its plans have to change, often due to bad weather or problems on other works in the same programme which can have a knock on effect. Highways undertake to advise Godalming Town Council if anything changes with the details of these works. 
