6. STRATEGIC CIL FUNDING – ITEM FOR NOTE

Members will wish to note that of the two projects currently being supported by Neighbourhood CIL funds, which also applied for Strategic CIL funding, neither have been successful in their bid.

Impact:

Busbridge Junior School: GTC made provision for funding of up to £125,000 subject to reduction if Strategic CIL funds were awarded. The award from GTC allows this project to proceed.

Broadwater School: GTC provided up to £79,400 for the Canopy Garden element of this project. This element can proceed without Strategic CIL funding. However, indications from the project team are that they may wish to engage with GTC to seek changes to amend the overall project design. Any future proposal affecting the project that funding has been granted for will be brought to Council for consideration.

7. <u>CIL APPLICATION – FARNCOMBE COMMUNITY GARDEN – **ITEM FOR DECISION**</u>

Recommendation: The Environment & Planning Committee is requested to consider the Neighbourhood CIL application in support of the Farncombe Community Garden Project and, if approved, to resolve to recommend the application to Full Council for an award of £10,000 Neighbourhood CIL

Members are requested to consider the Neighbourhood CIL application for the Farncombe Community Garden Project (attached for the information to Members), which requests an award of $\mathfrak{L}10,000$ towards the cost of building accessible pathways throughout the garden. This will make the garden accessible and safe to the public and enable the garden to be open to everyone in the community.

In considering the application, Members will wish to note that, at present Godalming Town Council has awarded £227,400 of Neighbourhood CIL funding. As of 14 March 2023,

Neighbourhood CIL monies received from developers via WBC for the Parish of Godalming stands at £241,522. Therefore, the current uncommitted amount available to support this application is £14,122. If Members were to support this application the CIL balance would be £4,122.

Whilst not yet received an additional £138,447 has been collected by WBC but not yet disbursed (due end March 2023).

The regulations that govern how CIL is spent require that Godalming Town Council utilises the local CIL allocated towards either:

- the provision, improvement, replacement, operation or maintenance of infrastructure, or
- anything else that is concerned with addressing the demands that development places upon Godalming.

These definitions allow GTC and the local community to consider quite broadly what is needed to help to mitigate the impacts of development in Godalming. The definition of infrastructure is broad and includes roads and other transport infrastructure, schools and other educational facilities, medical facilities, sporting and recreational facilities and open spaces.

8. SCC FUTURE BUS SERVICE - POST CONSULTATION PROPOSALS - ITEM TO NOTE

Members will recall that on 15 December 2022, following consideration of SCC proposals put forward as part of the Future Bus Service review, Members expressed concerns about the proposed reductions in the county's bus services and the impact they would have at a time when use of bus services should be promoted and encouraged as a means of meeting the county's climate change challenge and when residents are having to deal with a cost of living crisis. Members considered that the withdrawal of local bus services could create even more challenges for many residents.

GTC's concerns related to the withdrawal of the No. 42 route service from Catteshall Lane, the only service linking the residential areas of the town with The Mill Medical Practice and the potential alteration to the service for Godalming College. Additionally, GTC raised concerns regarding the proposal to withdraw early morning and evening services on the 70/71/72 route.

The outcome of the consultation is due to be considered by the SCC Community, Environment and Highways Select Committee on 20 March, see Agenda for Communities, Environment and Highways Select Committee on Monday, 20 March 2023, 12.00 pm - Surrey County Council (surreycc.gov.uk). Members will wish to note the changes between the consultation proposals and the final proposals shown in the table below to be considered by the Committee. It is hoped that Members can be informed of the SCC's decisions at the E&P meeting.

Of the consultation survey responses received by SCC, the second highest level was from the Waverley area (Guildford being the highest), with the No 70/71/72 route being the second highest used route by survey respondents. The No. 42 route was the 14th most used. The GU6, GU7 & GU8 postcode areas, which are served by route 42 and route 70/71/72 accounted for over 60% of the responses from the Waverley Borough area. Whilst the consultation was promoted via several sources, Members will wish to note that GTC's social media campaign to raise awareness of the consultation reached 1,850 accounts.
