376. TEMPORARY TRAFFIC ORDER – GREEN LANE, FARNCOMBE (D98)

Members noted that Surrey County Council had written to inform Godalming Town Council of the above temporary road closure, the effect of which would be to temporarily prohibit traffic from entering or proceeding along that length of (D98) Green Lane, Farncombe, between its junction with Binscombe and its junction with Long Gore, a distance of 430 metres.

This Temporary Traffic Order is required to enable Surrey County Council to carry out major highway repairs and/or surface treatment works. These works are anticipated to be carried out as soon as possible between the hours of 08.00hrs and 16.00hrs within the eighteen-month period of operation of this Temporary Traffic Order that commences on 28 November 2016. Advanced warning signs will be displayed and the temporary closure will only operate when the relevant traffic signs are displayed. Access will be maintained for pedestrians, residents and emergency vehicles at all times.

Vehicular traffic will be diverted via Binscombe, New Pond Road, Furze Lane and Green Lane.

Members received an update from Councillor Walden noting that the Ad Hoc Advisory Group had met on Monday 21 November. Two groups had completed their work and a deadline of 12/19 December 2016 had been set for the remaining groups to submit their work.
