## 9. GARDEN OF REMEMBRANCE

The current Garden of Remembrance (GoR) at Eashing Cemetery was opened in 1966, since then records show that 199 interments of cremated remains have been conducted. The GoR provides an affordable option for those who wish to have a focal point for remembrance of a loved one and also provides an opportunity to have a memorial tablet. At the current level fees, interments into the GoR are valued at £23,880.

An alternative option for interment of cremated remains is available within the cemetery by utilising an ashes plot within the main cemetery (these have been created from what were originally intended to be child graves), however, this option is nearly three times as expensive.

The current GoR is reaching capacity and as such officers recommend that Members agree for officers to bring forward options for the provision of a new GoR and the 'Closure' of the current GoR.

## 10. MEETING START TIMES

Due to the distances involved and the increased traffic with Godalming, officers recommend that for the two meetings per year where Members first conduct an inspection of the cemeteries that the inspection start time moves to 5.15 pm with the formal meeting starting at 6.00pm. The non-inspection meetings start time to remain at 5.30pm.
