# 40. SIGNING OF BANK RECONCILIATIONS

The Committee considered the tabled monthly bank reconciliations since the last meeting of the Committee and authorised the Chair to sign them.

## 41. <u>BUDGET MONITORING</u>

Members considered the budget monitoring report to 31 December 2020 and noted a current variance of £34,122 underspend against revised estimates.

December saw a higher than expected number of burials, which resulted in significant unbudgeted income.

## 42. RISK ASSESSMENT 2020/21

Members reviewed the Risk Assessment and agreed its contents.

Members noted that in addition to the risk assessment reviewed above, this Committee also relies upon the Risk Assessments performed by Godalming Town Council.

## 43. <u>CEMETERY MAPPING & BURIAL RECORDS</u>

Members resolved to approve the provision of a Cemetery Searcher system to provide an online virtual cemetery to assist in the searching and location of individual grave spaces at Nightingale and Eashing Cemeteries. The setup costs of  $\pounds 2,000$  to be met from funds allocated for digitisation and mapping and the ongoing costs to be built into the base budget going forward.

## 44. BURIAL STATISTICS

The Committee noted the burial statistics for the previous quarter and for the previous twelve months ended on 31 December 2020 (copy attached to record minutes).

## 45. JBC ADMINISTRATION AND STAFFING RESOURCE

Members resolved to accept the increase in the Godalming Joint Burial Committee administration charge for 2021/2022 payable to Godalming Town Council from £29,680 to  $\pounds$ 39,755.

## 46. <u>COMMUNICATIONS ARISING FROM THIS MEETING</u>

Members identified that when the Cemetery mapping is online, this should be promoted by social media and press release.
