158. WAVERLEY BOROUGH COUNCIL - PLANNING DECISIONS

Members noted the contents of a list of Godalming applications considered by Waverley Borough Council (either by delegated authority or by Development Management Committees) where decisions were significantly different to the observations submitted by the Town Council (copy attached to record minutes).

159. <u>TEMPORARY TRAFFIC MANAGEMENT ORDER (NO. 3) 2012 – HOLLOWAY HILL</u> (D169)

Members noted that Surrey County Council proposed to make the above mentioned Temporary Order under Section 14(1) of the Road Traffic Regulation Act 1984, the effect of which would be to prohibit vehicles from entering or proceeding in that length of Holloway Hill (D169), Godalming that extends from its junction with Ockford Road to its junction with Braemar Close.

This Temporary Traffic Order was required to facilitate the Surrey County Council to carry out major highway maintenance and surface treatment. These works were anticipated to be carried out between the hours of 09:30 and 16:30 within the twelve-month period of operation of the Temporary Order, which commenced on 24 September 2012. Advance warning detailing the precise dates for works would be displayed. The temporary closures and restrictions would only operate when the relevant traffic signs were displayed and would not all operate simultaneously. Access would be maintained for pedestrians, residents and emergency vehicles.

Alternative Route: Holloway Hill (D169), Godalming, vehicular traffic will be diverted via Ockford Road (A3100), Shackstead Lane (D5404) and Tuesley Lane (D169).
