## 1. MINUTES

The Minutes of the meeting held on the 23 March 2017, having been previously circulated, were signed by the Chairman as a true record.

# 9. BURIAL STATISTICS

The Committee noted the burial statistics for the previous quarter and for the previous twelve months ended the 31 March 2017, which had previously been circulated (copy attached to record minutes).

# 10. TREE WORKS

Members noted that application had been made for canopy lifting of trees located at Eashing Cemetery which are subject to Tree Preservation Orders.

Members agreed to allocate £2,500 for use during 2017/18 from the earmarked reserve for tree works in order to implement a programme of tree planting aimed at compensating for trees removed following safety inspection.

# 11. <u>NIGHTINGALE MEMORIAL GARDEN AREA</u>

Having inspected the area within Nightingale Cemetery, Members agreed to conduct preparatory works to improve the soil in the vicinity of the recently felled cedar tree.

Members also consented to allow Godalming in Bloom to run an open competition to design a Memorial Garden to commemorate those from Godalming who fell during the First World War. It was further agreed that the Chairman of the Committee plus one other Member to be on the judging panel, with the Joint Burial Committee having an ultimate veto of design.

Members agreed that in addition to ground preparation and assistance with implementation of the winning design £1,000 to be allocated towards materials and plants.

## 12. CEMETERY MANAGER'S UPDATE

Members received an oral report from the Cemetery Manager on maintenance and other activities since the last meeting, noting that both Cemeteries continue to be maintained to a high standard.

## 13. NATURAL BURIAL AREA

Members received an oral report and update on the Natural Burial Area of Eashing Cemetery and authorised the remapping of this area to achieve a greater utilisation of the available space.

The next meeting of the Godalming Joint Burial Committee is scheduled to take place on Thursday, 14 September 2017 at 6.00pm in the Council Chamber preceded by an inspection at Eashing Cemetery at 5.00pm.
