## 5. REVISED ESTIMATES 2012/13 AND PRECEPT 2013/14

A detailed budget report is attached for the information of Members. The Policy & Management Committee took the opportunity to look in detail at the budget figures on 10 January 2013. However, the matter was not able to progress to a recommendation to Full Council because Waverley Borough Council had not supplied tax base information crucial to the budget setting process. A letter containing that information was received from the Deputy Chief Executive of Waverley Borough Council on 15 January 2013 and that letter is also attached for the information of Members.

Members TO CONSIDER the budget report and to note that the recommended precept for 2013/14 is £454,058 being £11,031 higher than the precept for 2012/13. This represents an increase of 2.49% over last year and that increase is explained by the fact that 2013/14 is the first year that Godalming Town Council becomes responsible for funding 100% of the costs of the Godalming Co-ordinator post (Minute 316-11 refers).

It is recommended that Members AGREE the revised estimates for 2012/13 as set out in the attached papers and AGREE the budget for 2013/14 also in the attached papers.

Consequent on agreeing the budget for 2013/14 it is recommended that Members AGREE to set a precept of £454,058 for the financial year 2013/14.
