## 330. MINUTES

## 332. DISCLOSABLE PECUNIARY INTERESTS AND NON-PECUNIARY INTERESTS

Members made no declarations of interest in relation to any item on the agenda for this meeting, which is required to be disclosed by the Localism Act 2011 and the Godalming Members' Code of Conduct.

## 333. REVISED ESTIMATES 2012/13 AND BUDGET 2013/14

Members considered a detailed budget report and AGREED the revised Estimates for 2012/13 and a Budget for 2013/14 (copy of the agreed Budget attached for the information of Members and to the record minutes).

Consequent upon agreeing the budget for 2013/14 Members AGREED to set a precept of £438,506 for year beginning 1 April 2013. This precept is £4,521 less than the precept set for 2012/13 representing a reduction in cash terms of 1.02%

Members noted that following the localisation of support for council tax benefit the Town Council's taxbase had fallen by 7.42% and that while the Council had cut its expenditure plans for 2013/14 this reduced expenditure would nonetheless result in an increase in the amount individual households would have to contribute to the Town Council.
