348. MINUTES

349. PETITIONS/STATEMENTS/QUESTIONS FROM MEMBERS OF THE PUBLIC

Mr Paul Weightman and Mr Jonathan North of 29 Church Street Godalming were present and entitled to make a statement under Standing Order 80 about Agenda Item 5 Schedule Number 4 (WA/2013/0054), and requested that their statement be made by their agent, Mr Keily. As Mr Keily had no specific entitlement to speak under Standing Order No 80, the Chairman suspended Standing Orders to allow Mr Keily to make the statement.
