532. YEAR END OUTTURN FIGURES

Members noted that the Town Council's financial accounts for the year ending 31 March 2016 were closed on 19 April 2016 The final out turn figures were reported here for Members' information – and summarised in the table below.

Members to note that budget monitoring at the end of February 2016 (considered by the Policy & Management Committee on 24 March 2016) indicated a small overspend of £500. At the year end this figure had risen to £5,478 the increase being accounted for by the large (unbudgeted) expenditure in March on professional fees relating to The Square.

Members noted that the overspend of £5,478 was debited to the Revenue Reserve leaving that reserve at £194,522. Members AGREED the transfer of £5,478 from the earmarked reserve for The Square to the Revenue Reserve in order to return that reserve to £200,000. This transfer to take place in the current financial year (2016/17).
