# 163. MINUTES

# 164. PETITIONS/STATEMENTS/QUESTIONS FROM MEMBERS OF THE PUBLIC

#### 165. <u>DISCLOSABLE PECUNIARY INTERESTS AND NON-PECUNIARY INTERESTS</u>

Members made no declarations of interest in relation to any item on the agenda for this meeting, which is required to be disclosed by the Localism Act 2011 and the Godalming Members' Code of Conduct.

#### 166. WORK PROGRAMME

Members received reports from Councillor Thornton relating to Payroll Controls, VAT, Income Controls, Proper Booking, Payment Controls and Petty Cash. It was agreed that as the regulations surrounding making payments within Local Government are imminently about to change the Responsible Finance Officer should continue investigating the best and most economic way to make payments by BACS.

#### 168. EXTERNAL AUDIT

Members received the reports from the External Auditor for both the Godalming Town Council and the Godalming Joint Burial Committee for the financial year ending 31 March 2012.

Members declared their disappointment that the Godalming Town Council's Accounts had been qualified as the Annual Return had not been approved by Full Council. Members were disappointed that the mechanism of advice from NALC had failed to alert officers to the fundamental change that the accounts were now required to be approved by Full Council by 30 June each year. It was agreed that a process needed to be put in place to ensure that any future fundamental changes were picked up and actioned in due time (copies attached to record minutes).
