Members noted a report from Councillor Wheatley on the Godalming/Mayen Association (copy attached to record minutes) an organisation on which Councillor Wheatley represents the Town Council.

423. APPLICATIONS FOR GRANT AID

Members considered the following applications for grant aid and decided upon them as indicated.

Farncombe Youth Football Club

£958.80 was granted to meet the costs of repairing and replacing connections on The Burys Field floodlights and to replace all lamps.

Godalming District Scouts

£700 was granted to assist with the costs for a Jubilee street party (badges/bunting) to be held in conjunction with Godalming Girl Guides. This application was granted on the basis that Godalming District Scouts are providing free of charge the marquees for the Town's Diamond Jubilee celebrations.

Godalming Museum Trust

£4,600 was granted to assist with the provision of a Volunteer Co-ordinator. Members indicated that they wished the Town Clerk to explore options other than an annual grant application with the museum for future funding of the Volunteer Co-ordinator.

Rodborough School

£300 was granted to provide opportunities for young people to research the Arts & Crafts Movement within Surrey with the help of Godalming Museum.

The Cellar Café

£800 was granted to assist with the costs of providing a 4-night holiday to the Isle of Wight for six regular customers who are particularly disadvantaged.

Wey Valley Amateur Radio Group

£500 was granted to assist with the costs of running a commemorative international radio station and exhibition constructed at Charterhouse to honour the heroism of Jack Phillips and to which the general public will have access on two successive days.

424. GRANT AID IN KIND

Members agreed that as current recipients of Grant Aid in Kind the following organisations could be considered for Grant Aid in Kind on the same basis as last year without the individual organisations needing to complete a new application form.

Godalming Round Table

£100 Grant Aid in Kind was granted in the form of ten hours free use of the Wilfrid Noyce Centre on Saturday, 2 June 2012 in order to facilitate the Town Show.

Godalming Together Community Interest Company

£210 Grant Aid in Kind was granted in the form of free use of The Pepperpot for fifteen twohour meetings during 2012/13.

The Godalming Trust

Free use of the Pepperpot Upper Room over the weekend of 8 & 9 September 2012 (Heritage Open Days) was awarded.

GO Godalming Association

Free use of the Pepperpot Upper Room for the association's quarterly committee meetings was awarded – a total of 12 hours at a value of £84 a year.
