#### 29. THE 20's PLENTY FOR GODALMING CAMPAIGN

- The Planning & Environment Committee does not believe that the campaign objective
  of introducing a 20 mph speed limit throughout Godalming is either sensible or
  affordable. Nor, more importantly, is it the most effective way of reducing speed and
  accidents and improving safety on Godalming's roads.
- The Planning & Environment Committee supports the approach adopted by the County Council and the Police (as set out in the Council's published Speed Management and Speed Limit policies), which provide a more realistic and balanced approach to speed management based on national evidence of what actually works.
