351. GODALMING JOINT BURIAL COMMITTEE

The report of the meeting of the Joint Burial Committee held on 10 November 2016 was noted.

352. WILFRID NOYCE CENTRE IMPROVEMENT PROJECT – PHASE 2

Members considered a report from the Deputy Town Clerk and the Responsible Finance Officer and AGREED the following:

- To implement Phase 2 of the Wilfrid Noyce Centre Refurbishment Project as detailed in the attached reports and tabled plans;
- That the Town Clerk acting as Responsible Finance Officer should make application to the Department for Communities & Local Government (DCLG) via the Surrey Association

of Local Councils for approval to borrow up to £300,000 (over a 29.5 year period based on an annuity loan from the Public Works Loan Board) in order to complete Phase 2 of the Wilfrid Noyce Centre Improvement Project;

- That £20,000 should be earmarked in reserves for this project (the detail of the movements between reserves to create the earmarked reserve to be considered alongside the revised estimates for 2016/17 and the budget for 2017/18);
- Drake & Kannemeyer LLP should be appointed to undertake stage 2-5 Design Consultancy Services for Phase 2 of the Wilfrid Noyce Improvement Project and CDM 2015 principle designers and that this be conducted as soon as is reasonably practicable in order for the acceptance of tender recommendation report to be put to the Policy & Management Committee on 23 February 2017; and
- Exploratory investigation to determine soil contamination levels should be undertaken at a cost of £1.450.

353. GODALMING MUSEUM - TRANSFER OF RESPONSIBILITY

Further to the deliberations of the Policy & Management Committee referred to above, Members RECEIVED a confidential report on the proposal to transfer responsibility for Godalming Museum from Waverley Borough Council to Godalming Town Council. That report included a condition survey of the museum building; Members AGREED to defer this item to the confidential part of the agenda (Minute 358-16 below refers).
