258. <u>TEMPORARY PROHIBITION OF TRAFFIC ORDER 2013 – LATIMER ROAD (D5427),</u> GODALMING

Members noted the following that:

THE SURREY COUNTY COUNCIL PROPOSED TO MAKE the above mentioned Temporary Order under Section 14(1) of the Road Traffic Regulation Act 1984, the effect of which would be to prohibit vehicles from entering or proceeding in the entire length of Latimer Road (D5427), Godalming and/or any part and/or parts therein.

This Temporary Traffic Order was required to facilitate The Surrey County Council to carry out highway maintenance and/or surfacing works. These works were anticipated to be carried out as soon as possible within the twelve-month period of operation of this Temporary Traffic Order that commenced on 18 November 2013. Advanced warning signs would be displayed and the temporary closure would only operate when the relevant traffic signs were displayed.

Access would be maintained for pedestrians and emergency vehicles at all times. Access would be maintained for residents, businesses, buses and H.G.V.s where reasonably possible however in the event that it was necessary to restrict any access at any time under Section 3 of the Road Traffic Regulation Act 1984 the road could only be closed for a maximum of 8 hours in any 24-hour period. Any vehicle found to be obstructing the highway during these works would be removed to a suitable location outside the limits of the works after all reasonable methods had been undertaken to identify and contact the vehicle's owner.

Vehicular traffic would be diverted via Brighton Road (B2130) and Croft Road (D5427).
