# 1. MINUTES

The Minutes of the meeting held on the 24 March 2016, having been previously circulated, were signed by the Chairman as a true record.

### 4. NIGHTINGALE CEMETERY CHAPEL BUILDINGS RE-ROOFING

Members recorded their thanks to the Cemeteries Manager for management of the project and asked that their thanks be sent to Drake & Kannemeyer the Committee's surveyors for their running of the contract.
