1. WA/2011/0008	Application under Regulation 3 for the erection of a replacement Leisure Centre with subsequent demolition of existing centre; alterations to elevations of cricket pavilion and relocation of multi use games area together with associated works. Land at Broadwater Park, Summers Road, Godalming Waverley Borough Council	Godalming Town Council strongly supports the need for a new Godalming Leisure Centre and has no objection to this application provided that the applicant deals with the issue of the inadequacy of the car parking provision on site. As currently drafted the application significantly misrepresents the amount of car parking space available to the new Leisure Centre. The statement at paragraph 3.5 of the Transport Statement is untrue. No agreement currently exists with the adjacent community centre (owned and managed by Godalming Town Council) for users of the leisure centre to use that car parking if necessary. Therefore the available car parking is overstated by 36 spaces.
2. WA/2011/0131	Erection of two storey rear extension. Westhanger Court, Westbrook Road, Godalming C Newnes-Smith	Object on the grounds of loss of visual amenity and loss of light to the adjoining property. The Town Council will be asking the Waverley Ward Councillor to refer this application to the appropriate Waverley Committee.
3. WA/2011/0139	Erection of attached garage with accommodation above following demolition of existing garage. 35 Quartermile Road, Godalming A Gee	No objection
4. WA/2011/0142	Erection of 7 dwellings with parking, bin/recycling stores and cycle stores following demolition of the existing dwelling. Groton, Ballfield Road, Godalming K Slater	Object on the grounds of loss of amenity to and overlooking of neighbours, overdevelopment, poor position of the bin stores to the detriment of the street scene and because the proposal will exacerbate traffic congestion and parking problems in the area.
