#### 54. MINUTES

#### 57. ACCOUNTS PAID SINCE LAST MEETING

The Finance Officer reported payments totalling £6,454.00 since the last meeting.

#### 58. REVISED ESTIMATES 2011/12 AND BUDGET 2012/13

Members noted that as there are still amounts and calculations required relating to the detailed income and expenditure budget for the financial year 2012/13 this item will be brought to the next meeting on 12 January 2012 to be finalised.

#### 59. INTERNAL AUDIT REVIEW, AUDIT WORKPLAN AND LETTER OF ENGAGEMENT

Members noted that the interim Internal Audit was conducted on 1 November 2011 by Mark Mulberry and that the Internal Audit Workplan, for the year 2012/13 was submitted by the Internal Auditor for approval for the financial year 2012/13. Members considered the Interim Audit report and the Audit Workplan for Godalming Joint Burial Committee and agreed that it was content that, in accordance with the decision of the Godalming Town Council's Policy & Management Committee meeting on 17 November 2011, the Chairman of that committee signed the Letter of Engagement on behalf of the Godalming Joint Burial Committee and Godalming Town Council on 26 November 2011.

# 60. <u>EXTERNAL AUDIT FOR THE FINANCIAL YEAR 2011/12 AND THE REPORT FROM THE AUDIT SUB COMMITTEE</u>

Members received the Annual Return and the External Auditor's (BDO Stoy Hayward) report relating to Godalming Joint Burial Committee accounts for the year 2011/12, Members also received the draft minutes of the Audit Sub Committee meeting held on the 3 October 2011 and the Extraordinary meeting held on the 3 November 2011.

Members' attention was specifically drawn to the fact that a significant change to the regulations of The Accounts and Audit (England) Regulations 2011 came into force on 31 March 2011. As a result the Committee was asked to consider an Officers' recommendation that based on the generality of the Audit Sub Committees' discussions, and in order to fulfil its duties under The Accounts and Audit (England) Regulations 2011, Godalming Joint Burial Committee should consider the Audit Sub Committee's findings from its review of the effectiveness of the systems of internal control at a meeting of the Joint Burial Committee by 31 March each year. Members accepted this recommendation and agreed that this item will be reviewed at the meeting of the Joint Burial Committee on 12 January 2012.

#### 61. AWARD OF GROUNDS MAINTENANCE CONTRACTS

Members accepted Officers' recommendations for the awarding of the Grounds Maintenance Contracts and agreed to continue with the practice of splitting the Grounds Maintenance Contracts between two companies. Members thanked Officers for managing the tender process and instructed the Cemeteries Manager, subject to satisfactory precontract negotiations, to award the following contracts:

Nightingale Cemetery – Hardings Management Ltd Eashing Cemetery – G Burley & Sons Ltd Godalming Town Council Open Spaces – G Burley & Sons Ltd

Additionally Members agreed that if pre-contract negotiations with Hardings Management Ltd are unsatisfactory then the company identified as Company B is to be offered the contract for Nightingale Cemetery.
