371. GODALMING TEMPORARY NO WAITING ORDER 2015 – BRIGHTON ROAD (B2130)

Members noted the following information from Surrey County Council:

“SURREY COUNTY COUNCIL PROPOSE TO MAKE the above mentioned Temporary Order under Section 14(1) of The Road Traffic Regulation Act 1984, the effect of which will be to temporarily prohibit any vehicle from waiting at any time in that length of the western

side of Brighton Road that extends from the northern property boundary of No. 46 Brighton Road to the northern property boundary of No. 58 Brighton Road.

This Temporary Order is required to enable "77 Build Limited" to construct four town houses. These works are anticipated to be carried out between the hours of 08:00 and 18:00 within twelve months of the fourteen-month period of operation of this Order that commences on 16th February 2015. The temporary waiting restrictions will only operate when the relevant traffic signs are displayed and advanced notification will be given.

Any vehicle being used in connection with the works will be exempt from the temporary waiting restrictions described in paragraph one and the usual exemptions for Post Office vehicles when delivering or collecting postal packets, vehicles when waiting because they are required by law to stop, are obliged to stop in order to prevent an accident or are prevented from proceeding because of circumstances outside the drivers control and in respect of anything done with the permission or at the direction of a police constable in uniform or of a parking attendant will apply when the temporary waiting restrictions described above are in force."
