7. BUDGET MONITORING

Members to consider the attached budget monitoring report for the first five months of the current financial year – to 31 August 2016. Members are asked to note that all expenditure and income for the year to date is broadly in line with that expected at this time of year. The Clerk will answer any question of detail at the meeting but offers the opinion that there is nothing in the budget monitoring report that gives cause for concern.

8. BURIAL STATISTICS

Burial statistics for the previous quarter and for the twelve months ending 31 August 2016 are attached for the information of Members.

9. REPLACEMENT OF FLOOR NIGHTINGALE CEMETERY CHAPEL

Members will recall, during the previous inspection of Nightingale Cemetery, the Cemeteries Manager brought to Members' attention the condition of the wooden flooring in the chapel kitchen and that the replacement of the flooring would be brought to this Committee as programmed works.

Unfortunately, whilst conducting a security inspection of the chapel buildings during Skillway's summer recess, the floor was found to be in such a poor condition that immediate repairs were necessary in order to make this area safe for use (photograph attached for the information of Members).

Having consulted with the Chairman of this Committee, the Clerk exercised her delegated authority, on grounds of urgency, to instruct contractors to undertake immediate repairs at a cost of £2,441. This cost to be met from the additional income generated this year to date by the sale of Nightingale Cemetery plots. Additionally, Members are asked to agree that once the base has fully cured, a floor covering should be laid, the cost of which (estimated at £600) will also be met from Nightingale revenue. Total revenue in excess of that budgeted for is £4,740 at 31 August 2016.

10. EASHING CEMETERY CREMATED REMAINS PLOTS

At its meeting of 16 June 2016, Members noted that the current Garden of Remembrance is reaching capacity and authorised officers to investigate and bring forward options for the provision of a new Garden of Remembrance (GoR) and the 'Closure' of the current Garden of Remembrance.

For many of the bereaved the place of interment of cremated remains provides a focal point and somewhere that they are able to commemorate the deceased and lay floral tributes.

Whilst the GoR, in its current form, provides for the interment of cremated remains, its design does not provide the same level of 'personal' connection provided by an individual grave space.

Currently the alternative to the Garden of Remembrance is to utilise grave spaces within the main body of the cemetery. In many cases interment is in a pre-existing family grave, the cost of doing so ranging between £320 and £440 depending on fees relating to the headstone. For those without a pre-existing family grave, cremated remains may be interred in an area of the cemetery that traditionally would have been allocated for 6' x 3' graves. The cost of this option, including purchase of the grave, interment fees, grave preparation and permit for the installation of a grave marker is £650. The space available within suitable 6' x 3' grave plots is limited and the use of these graves for cremated remains reduces the availability of inhumation space.

In order to provide an option that would achieve a 'personal' connection, reduce the utilisation of 6' x 3' grave plots and enhance the cemetery, it is proposed that a dedicated area is created for the provision of 'ashes plots' which allow for the installation of a grave marker over a designated space.

There are two potential areas available for the creation of this space, being the scrub land either side of the driveway in front of the cemetery buildings. To achieve the maximum benefit it is proposed that the area is opened up by removing some of the surrounding hedges and trees, levelling the ground to provide easy access and casting cemetery beams for the installation of grave markers. This would create 144 spaces for the interment of ashes.

If Members are minded to approve the creation of additional dedicated ashes plots it is suggested that, once created, the fees are set at £440 which would include, purchase of a plot, interment fee, grave marker permit (if applied for at the same time as interment application) and grave preparation fee. Excluding the grave preparation fee, the income at current prices for the 144 plots would be £53,280.

One quote has been obtained for the required works at a cost of £17,445 further quotes are waiting to be received. Members are requested to agree to the creation of new ashes plots and to approve expenditure up to the cost of the received quotation plus a 10% contingency and to authorise the Clerk to place the work with the contractor offering the best overall value within the authorised funds.

#### 11. PURCHASE OF FURTHER PERIOD OF EXCLUSIVE RIGHT OF BURIAL

Members will be aware that private grave spaces within its cemeteries are sold with a 50-year exclusive right of burial. At the expiry of the initial period of exclusive right of burial the registered owner may purchase an additional period of exclusive rights (which cannot exceed a period of 100 years in total; Cemeteries Order 1977, Article 10(2)).

Prior to 2009, the potential to purchase additional burial rights was purely academic as the JBC sold private graves with 100 years burial rights attached. However, since 2009 the period was reduced to 50 years, therefore the first expiry of such rights will occur in 2059. At this point, if so requested, the JBC would be entitled to charge a fee for the purchase of further burial rights. Cemeteries where this system is already in operation tend to have offered much shorter initial rights, typically 30 years and offer further purchases of exclusive rights of burial of 10-year periods at a cost of approximately 33% of their current private grave purchase price. Officers do not recommend that Members either reduce the period of exclusive rights of burial or yet decide on a fee for further purchases. However, Officers would wish that Members consider a request from a current private grave owner to make a purchase of further exclusive rights prior the expiry of the existing burial rights.

The existing owner has made an enquiry regarding the purchase of further exclusive rights of burial on a grave which has 50 years of exclusive rights of burial remaining. However, notwithstanding that this committee has not yet set a fee or a length of time for such a purchase, allowing the purchase of a further period of burial rights before the expiry of existing rights would negate the rationale behind this committee reducing the period in the first instance. Experience has shown that the longer a period of exclusive rights the more difficult it becomes to trace an owner, therefore increasing the administrative burden and cost to the JBC in properly managing its cemeteries in relation to memorial safety. Additionally the selling of further periods of burial rights when in excess of even 10 years remaining has the potential to constrain the income potential of the cemeteries. Assuming the model of 33% of current private grave costs for a 10-year extension, a fee of £93 would have been received in 2006 for Eashing Cemetery as opposed to £200 at today's prices.

It is for the above reasons that officers recommend that further periods of exclusive rights of burial should not be granted until the expiry (or within 12 months preceding the expiry) of the existing burial rights.

However, if Members are minded to allow such purchases, officers recommend that the fee for each additional 10 year period (up to a total of an additional 50 years) should be set at:

- 150% of existing grave costs for existing rights in excess of 30 years
- 100% of existing grave costs for existing rights in excess of 20 years
- 50% of existing grave costs for existing rights in excess of 10 years
