7. BT CONSULTATION – PROPOSED REMOVAL OF THREE TELEPHONE BOXES IN GODALMING

Waverley Borough Council has informed town and parish clerks that BT has opened a consultation about the proposed removal of 46 payphones in the borough. BT would like to remove the payphones on the grounds that they are used infrequently and are expensive to maintain. A table of the affected payphones which gives the postcode, number of calls received in the last year and the relevant ward is attached for the information of Members. The three boxes in Godalming have been highlighted and are located at Deanery Road, Spring Grove and Bargate Rise (Aarons Hill). Photographs of all three are also attached for the information of Members. Notices have been placed in the affected payphones.

Town and parish councils are asked to forward their comments to Waverley Borough Council Ward Councillors before 23 December 2016. We are asked to indicate whether we object or agree to the removal of the payphone/s in question.

BT is not proposing to remove any payphones where it has identified a social need for retention such as accident blackspots, suicide hotspots or areas without mobile phone coverage. Additionally it will not remove where there is reasonable need and all three of the following apply - where it is the only payphone within 800m, had at least 12 calls in the last 12 months and local population is fewer than 500 households.

BT is aware that many people find the red phone boxes an important part of the local street scene. All three of the boxes identified in Godalming are red payphones, none of them are listed. If there are concerns about removal of red payphones, BT offer an 'adopt a kiosk' offer to local communities which it is worth considering.

Members are asked to consider what comments should be forwarded to the relevant Waverley Ward Councillors.
