#### Recommendations:

At its meeting of 29 May 2019, Members of the Mayoralty Committee considered an Officer's report relating to the condition of the Council's Civic Robes and the costs for repair or replacement as required. Following debate the Mayoralty Committee resolved to put forward the following recommendations to Full Council.

- 1. The Mayor should continue to be robed on external civic occasions.
- 2. The Mayor should wear robes at the Annual Meeting of the Council.
- 3. The Mayor should wear robes at the Ordinary Meetings of the Full Council.
- 4. Councillors should discontinue wearing robes.
- 5. The Clerk should continue to be robed but not wigged when supporting the Mayor whilst the Mayor is robed.

Additionally, at its meeting of 11 July 2019, the Mayoralty Committee considered possible options relating to symbols of office for the recognition of Council Members used on civic occasions, such as Remembrance Day, if Members are not wearing council robes. # The Motion: Climate Emergency & Biodiversity Motion

In recognition of the global climate emergency and to facilitate the reduction of carbon emissions, Godalming Town Council resolves to:

- 1) Commit to becoming a carbon-neutral organisation by 2030, to cover scope 1, 2 and 3 emissions<sup>1</sup>, including an earlier target of 2025 for all scope 1 and 2 emissions;
- 2) Set up an annual carbon audit to include the Council's carbon footprint and a roadmap for achieving this aim by the end of 2019;
- 3) Create a budget for grants to encourage and enable carbon-reduction and mitigation schemes within Godalming. The primary criterion for assessing applications to the fund should be CO2 savings per pound spent. The initial budget will be £10,000 for the 2019-20 financial year to be allocated from the Emerging Projects Fund;
- 4) Include environmental implications of recommendations in officer reports alongside legal, financial and equality implications. These will include the impact of recommendations on CO2 emissions as well as any other relevant environmental factors;
- 5) Seek ways to facilitate and encourage our community to reduce direct and indirect CO2 emissions and conserve and enhance biodiversity in order to become resilient to changes caused by the changing climate.

We will take active steps where possible to encourage:

- a) increased use of sustainable transport;
- b) reductions in energy use in homes, shops, businesses and elsewhere and a public education campaign in order to facilitate this;
- c) co-operation with organisations seeking to build sustainable developments that minimise carbon emissions;
- d) development and use of renewable energy sources;
- e) production, sale and consumption of locally sourced and sustainably produced food;
- f) any other methods of achieving the aims above: AND
- g) adoption of wildlife friendly land and water management practices.
- 6) Provide the appropriate training for council officers in order to implement the above.

# Recommendations: If Members resolve to support the Motion, it is recommended that the following actions are agreed:

- 1. The Motion should be considered by the Aims and Objectives Working Group to ensure the outcomes of that group are compatible with the Motion.
- 2. The Town Clerk should attend the Climate Change workshop being delivered by the Society of Local Council Clerks.
- 3. Members resolve to agree to engage The Carbon Trust to conduct a Carbon Emissions Audit to cover scope 1 & 2 activities at Godalming Town Council sites. A CO2e Audit would measure GTC's corporate emission footprint following Greenhouse Gas (GHG) Protocol Guidance, including direct emissions from fuel and processes (Scope 1 emissions) and those emissions from purchased electricity (or Scope 2 emissions) for the assets that GTC operate. As part of the process, Officers are to undertake appropriate training to enable future updating, review and reporting of GTC's CO2e emissions. The cost of the audit being approx. £3,000, cost to be taken from professional fees budget.
- 4. Members to consider and if agreed, adopt the Carbon Reduction Action Plan (attached for the information of Members).
- 5. Officers to work with Members to establish the application and approval criteria for the awarding of grants which encourage and enable carbon-reduction and mitigation schemes. The outcome proposals to be brought forward for consideration by the Full Council.
- 6. Officers to work with colleagues at WBC, SLCC and SSALC to establish best practice protocols for reporting environmental implications of recommendations.

# Climate Emergency & Biodiversity Motion Background Paper from Councillors Adam, Crooks, Purvis, Wardell and Williams

# **IPCC** report and context

The Intergovernmental Panel on Climate Change (IPCC) released a special report in October 2018<sup>1</sup> on the subject of 'Global Warming of 1.5°C'. The report is an international effort to summarise the current scientific consensus on how society might limit global warming to 1.5 degrees, as well as the likely consequences of this and greater levels of warming. The report states that:

- human activity has already caused 1°C of warming to the earth.
- to limit warming to 1.5°C it will be necessary to halve global carbon emissions by 2030 and to achieve near-zero net emissions by 2050.
- the consequences of 2°C warming are significantly worse than 1.5°C warming across all areas considered in the report.

At present, humanity is falling far short of the action necessary to limit warming to even 2°C. The likely global failure to achieve this target would result in increasingly severe consequences including very large scale water and food shortages, widespread flooding, heat related morbidity and large scale destruction of the natural world. These would result in substantial political and economic instability. The magnitude of the changes is difficult to quantify exactly, but the likely results are grave, both internationally and more locally. These changes are already in progress, and unless curtailed are likely to severely affect all of society before the end of the century.

#### **IPBES** report and context

In its recent report the Intergovermental Science – Policy Platform on Biodiversity and Ecosystem services<sup>2</sup> highlighted `natures dangerous decline and unprecedented rates of species extinction that are accelerating. It identified that the current global response is `insufficient` and transformative changes were needed to restore and protect nature.

These concerns are echoed in the Governments 25 year plan for the environment<sup>3</sup> which states that "We are in danger of presiding over massive human-induced extinctions when we should instead be recognizing the intrinsic value of the wildlife and plants that are our fellow inhabitants of this planet."

In recognition of this crisis the Prime Minister has stated the ambition to `become the first generation to leave the environment in a better state than we found it and pass on to the next generation a natural environment protected and enhanced for the future. The Town Council has a critical role in helping to achieve this locally.

# Our place in reducing CO2 emissions and Biodiversity decline

Godalming Town Council must acknowledge the urgent need for global society to reduce carbon emissions and conserve biodiversity. We need to recognise the part which we have to play and commit to taking an active role in achieving this, by:

- Lead by example by proactively reducing our CO2 emissions as an organisation and improving biodiversity across our estate
- seeking to encourage and enable our community to decrease their emissions and improve their resilience to climate change and enhance wildlife
- reducing the purchase of animal products derived from livestock where the intensive breeding of such livestock has a significant impact on the carbon footprint
- seeking to influence the policies of other organisations such as Waverley Borough Council
  to encourage them to reduce their emissions and enhance biodiversity and also support any
  decisions they might take to pursue a similar policy (see item '5(c)').

The Council must acknowledge that 'business as usual' is not an option in the face of this climate and biodiversity emergency, and that society in its current form is unsustainable. Therefore, to meet our obligations above, we will need to assess and adjust our current activities both in terms of their scope and how we are undertaking them.
