Notification by Member of Pecuniary and Other Interests

GIVE NOTICE that I or my spouse or civil partner (or a person with whom I am living as husband and wife or as if we were civil partners¹) have the following

Disclosable Pecuniary Interests²

Employment

Any employment, office, trade, profession or vocation carried on for profit or gain

TEACHER, GODALMING COLLEGE

Sponsorship

Any payment or provision of any other financial benefit (other than from the Council) made or provided within the last 12 months in respect of any expenses incurred by me in carrying out duties as a member, or towards my election expenses.

Contracts

Any contract which is made between me or my spouse/partner (or a body in which that person has a beneficial interest) and the Council (a) under which goods or services are to be provided or works are to be executed; and (b) which has not been fully discharged.

Land

Any beneficial interest in land (eg. my home) which is within the Council's area.

Licences

Any licence (alone or jointly with others) to occupy land in the Council's area for a month or longer.

Corporate Tenancies

Any tenancy where (to my knowledge)

- (a) the landlord is the Council; and
- (b) the tenant is a body in which I or my spouse/partner has a beneficial interest

Securities

Any beneficial interest in securities of a body where—

- (a) that body (to my knowledge) has a place of business or land in the Council's area and
- (b) either
 - (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
 - (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which I or my spouse/partner has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

Non-pecuniary interests that arise from my membership of or my occupation of a position of general control or management in the following bodies

Bodies to which I have been appointed or nominated by the Council

Bodies exercising functions of a public nature
