582. NEIGHBOURHOOD CIL APPLICATION

Members considered the recommendation of the Environment & Planning Committee for the awarding of Godalming Neighbourhood Community Infrastructure Levy Funding.

Following a proposal by Cllr Heagin, seconded by Cllr PMA Rivers, Members resolved to agree an amendment to the proposed draft letter to insert the following words "and impact on the local community" so that the second paragraph of the letter read..."A record of use of the MUGA by external organisations, showing the total number of hours of use and income generated is to be maintained by the management of the school and an anonymised summary of use and impact on the local community is to be provided to the Council 12 months following the completion of the project and thereafter, during the lifespan of the MUGA, within 14 days upon any future request of the Council."

Having agreed the amendment to the letter of offer, Members resolved to agree to approve the following:

- a) An award of Neighbourhood CIL funding of up to £60,000 to Busbridge Junior School for the provision of a Multi-Use Games Area as detailed within their application, such award to be conditional upon acceptance of the Godalming Neighbourhood Community Infrastructure Levy Funding - Terms and Conditions and the requirements of the amended Letter of Offer.
- b) The Godalming Neighbourhood Community Infrastructure Levy Funding Terms & Conditions document (Issue 1-28 April 2022) (copy attached to record minutes).
- c) The amended Letter of Offer for Godalming Neighbourhood Community Infrastructure Funding to Busbridge Junior School (copy attached to record minutes).
