### Question from Mr Chris Cook - resident

In committee 21 March 2024 the GTC planning Committee summarised their assessment to Planning Application WA/2023/02158 (Oflick) as:

"This application, if approved, would result in significant harm to neighbouring properties and to future occupiers of the properties themselves."

Between the sitting of the GTC Panning Committee 21 March 2024 and the subsequent sitting 13 June 2024 no material changes to plans against application WA/2023/02158 were submitted (my letter of 31 July 2024 – attached - refers).

Despite no material change to plans between the two sittings, by the second sitting 13 June 2024, the objections appears to have evaporated.

My question to the Godalming Town Council Planning Committee, as per my letter of 31 July 2024 and as reflected in my letters posted to the Waverley Planning Portal on two occasions, 14 June 2024 and 24 June 2024, remains unchanged:

On the basis of the chronology above I kindly request an explanation of the determination by the GTC Planning Committee 13 June 2024.

### WA/2024/01315 – Westbrook Mills, Borough Road, Godalming.

Application under Section 73 to vary condition 1 (approved plans), condition 16 (landscape and tree planting); removal of condition 18 (LEAP) and condition 15 (scheme for internal works to stairwell) of WA/2020/0682 to allow alterations to site plan, revised landscape plan to remove LEAP, scheme fully residential condition 15 not required; rewording of remaining conditions to reflect discharged conditions.

### WA/2024/01470 - Robert Dyas, 21-23 High Street, Godalming GU7 1AU

Application for advertisement consent to display 2 non-illuminated replacement fascia signs and 1 non-illuminated replacement projecting sign.

### WA/2024/01438 -15 Owen Road, Farncombe, Godalming

Erection of 6 dwellings in 2 blocks with associated parking and landscaping following demolition of existing building.

The full schedule of planning applications received from the Local Planning Authority since the last meeting is attached for the information of Members.

# 7. PLANNING APPLICATIONS – SUBJECTED TO AMENDMENT

There are no planning applications previously considered by this committee for which subsequent amendments have been submitted.

### 8. GTC CARBON AUDIT 2023/24 – ITEM FOR NOTE

Members to receive the Godalming Town Council (GTC) Carbon Audit Report for the period 1 April 2023 - 31 March 2024 (attached for the information of Members).

Increased activity and heating requirements over 2023/24 saw a noticeable increase in energy requirements compared to the previous year. 2023/24 was also the first year of the cemeteries energy and fuel requirements falling within GTC's carbon footprint calculations. However, GTC's carbon footprint in 2023/24 was still 28% less than its datum year 2018/19. It is expected that a marked and permanent decrease in Source 1 energy use will be achieved once the decarbonisation of Broadwater Youth Centre and the Pepperpot is completed. GTC should also see the benefits that will be gained from the removal of diesel vans used by GTC maintenance staff and from the solar power generated at Broadwater Youth Centre.

# 9. <u>HERITAGE FEATURES</u>

On 11 July 2024, Members considered documents provided by Waverley Borough Council explaining the different reasons why an Heritage Feature (HF) would be removed from the HF list and agreed to review the Heritage Feature list for Godalming and to provide the Town Clerk with any corrections or notes by 1 August so that a consolidated response can be approved by this committee at its meeting of 15 August before forwarding it to WBC (Min No 116-24 refers).

At the request of Cllr Heagin it was agreed that the Town Clerk would email the list in spreadsheet format, that is searchable by Council wards. It was felt this would assist Members to more easily find HFs located within their wards (list attached for the information of Members). Cllr Follows requested that what3words /// also be added to ease identification of location. The spreadsheet, that was created by work experience pupils from Broadwater School was distributed on Monday, 15 July. Whilst the spreadsheet with ///what3words was created using the grid references provided, it would appear that a number of the grid references are incorrect. Where the office has been informed of potential errors these have been investigated and comment provided so that the master list at WBC can be amended.

Members have been exploring their wards to identify HF's on the list, noting the challenge of incorrect grid references, the majority of HF's have been located, either by correct grid references ///what3words or utilising the physical description. it would appear the reasons identified in the spreadsheet for removal from the HF list are correct and at present Members have identified no HFs whose removal from the HF list should be challenged.

### Planning Application WA/2023/02158 (Oflick)

- 1. I wonder if you can help resolve a query I have over planning application WA/2023/02158?
- 2. At Godalming Town Council's (GTC) Environment & Planning Committee 21 March 2024, the Planning Committee raised a series or profound and weighty objections to Planning Application WA/2023/02158, including a series of conflicts with the Godalming & Farncombe Neighbourhood Plan Policy, in particular clause GOD5:
- 3. "Overall, GTC maintains its objection to this application. It conflicts with the Godalming & Farncombe Neighbourhood Plan Policy GOD5, particularly the parts that call for:
  - a. Sympathy with the scale mass height and form of neighbouring properties
  - b. Avoidance of the appearance of cramming by reflecting existing plot widths within the street
  - c. Responsiveness to the existing street scene"
- 4. The GGTC Planning Committee concluded its assessment with the statement:
  - a. "This application, if approved, would result in significant harm to neighbouring properties and to future occupiers of the properties themselves."
- 5. These weighty and profound objections were released to the Waverley Planning Portal on 26 March 2024.
- 6. The plan (0802 SK-01 F) extant immediately prior to the 21 March 2024 session of the GTC Planning Committee is at Enclosure 1.
- 7. Following the release of these objections, 11 new documents pertaining to WA/2023/02158 were released to the Waverley Planning Portal. These documents are listed at Enclosure 2, with the changes as described by those same documents.
- 8. The GTC Environment & Planning Committee sat again 13 June 2024 to reconsider planning application WA/2023/02158 based on changes to plans submitted since the 21 March 2024 sitting. On this occasion, Committee Members raised no objections to the submitted amended.
- 9. The plan (0802 SK-03 F) extant immediately prior to the 13 June 2024 session of the GTC Planning Committee is at Enclosure 3.
- 10. The basis of my query is as follows:
  - a. Objection at 3a above has not been addressed in any meaningful way in revised plans submitted between GTC's sitting 21 March 2024 and 13 June 2024: **the scale and mass on the three properties did not change between the two sittings**.

- b. Objection at 3b above has not been addressed in any meaningful way in revised plans submitted between GTC's sitting 21 March 2024 and 13 June 2024: **no change the appearance of cramming within the street at 13 June 2024 and 21 March 2024.**
- c. Objection at 3c above has not been addressed in any meaningful way in revised plans submitted between GTC's sitting 21 March 2024 and 13 June 2024: lack of responsiveness to the existing street scene at 13 June 2024 and 21 March 2024 are the same.
- 11. On this basis (that no material change to plans has taken place between the two sitings), the conclusion arrived at by the GTC Planning Committee 21 March 24 must remain extant:
  - a. This application, if approved, would result in significant harm to neighbouring properties and to future occupiers of the properties themselves.
- 12. Once the 13 June "no objection" determination had been released to the Waverley Planning Portal, 14 June 2024, I submitted a query (at Enclosure 4) seeking confirmation that, on the basis laid out at Paragraph 10 (above), the profound and weighty objections raised by the GTC Planning Committee would be taken forward into deliberations by the Waverley Planning Committee.
- 13. On 20 June 2024, following my request for re-assurance 13 June 2024, the same statement as that of 14 June 2024 was reposted.
- 14. Clearly this did not address my question, which I posed a second time 24 June 2024 (Enclosure 5).
- 15. No response to my second request was received, and Waverley released its approval for plans onto the portal 25 July 2024.
- 16. On the basis of the chronology above, I kindly request an explanation of the determination by the GTC Planning Committee 13 June 2024.





However, GTC's carbon footprint in 2023/24 was still 28% less than its datum year 2018/19. It is expected that a marked and permanent decrease in Source 1 energy use will be achieved once the decarbonisation of Broadwater Youth Centre and the Pepperpot is completed. GTC should also see the benefits that will be gained from the removal of diesel vans used by GTC maintenance staff and from the solar power generated at Broadwater Youth Centre.

Broadwater Youth Centre continues to thrive, and is used daily throughout the year at an intensity not seen since the centre opened in the early 90's. However, despite a much greater usage, including multiple computer systems, music studio, gaming consoles and greater use of the kitchen and cooking facilities, the changes made over the last few years to control systems, updating to PIR sensors and LED lighting has seen an overall reduction in energy use of nearly 8,500kwh since 2018/19. Broadwater also now benefits from self-generated electricity provided by the solar panels installed at the end of December 2023.

Since the solar panels were installed at the Youth Centre, up to 31 July 2024, a total of 4,140 kwh of energy has been generated and used by the centre. During the 7-month period 1 Jan – 31 Jul 2024 just 1,340 kwh of energy has been imported from the national grid, compared with 4,844 for the same period in 2023. The first full year of self-generation (April-March) will be reported following the end of the current financial year.

The recent approval for upgrading the incoming electricity supply at Broadwater Youth Centre to a 3-phase supply to enable the installation of air source heat pumps will, once complete, mean that Broadwater will join 107-109 High Street, the Farncombe and Crown Court Public Toilets and Eashing Cemetery, as council buildings with carbon neural energy requirements. The exchanging out of the gas combi to electric at the Pepperpot will also see that building becoming carbon neutral for energy. Broadwater and the Pepperpot accounted for 46% of GTC's Source 1 emissions in 2023/24.

Once the decarbonisation work is completed at Broadwater and the Pepperpot, the Wilfrid Noyce Centre will be the only directly managed GTC building with Scope 1 emissions. The WNC has seen regular user occupancy return to pre-covid levels and although the mild autumn of 2022/23 saw a reduction in the heating requirement, the colder autumn and winter 2023/24 saw demand increase, although the improved control system kept the demand below the 2001/22 level.

The highest proportional increase to GTC's carbon footprint was an increased use of diesel. This is in part due to the counting of the former Joint Burial Committee usage into GTC usage, the delay in transition to all electric vehicles by the maintenance team, and the addition of the Youth Activity Vehicle and Minibus, although it should be noted that Youth Vehicles only accounted for 785KgCO<sub>2</sub>e or 16% of the increase. The aim had been that, with the exception of the tractor, the GTC maintenance team's vehicles would be all electric by the end of 2023. Unfortunately, due to supply chain issues, this goal was not achieved until 5 August 2024. With the delivery of the electric tipper vehicle, GTC maintenance team's vehicles are now all electric powered.
