#### 165. ACCESSIBILITY REGULATIONS 2018

Due to a change in the regulations and in order to assess the Council's compliance with the revised regulations, a high-level accessibility review of the website was completed in October 2023. The review concluded that the Council's website is currently partially accessible. A total

of 3 general and 1 specific issue were identified, for those users most likely to encounter issues whilst navigating with a screen reader.

Work has already commenced to address some of the issues that are largely to do with design. All remaining issues are controlled by the theme and plugin creators which are used to build our website. We are continually liaising with the theme and plugin creators and will continue to do so in the hope that they can resolve the issues mentioned via their updates. Any issues unable to be resolved are noted in the Council's Accessibility Statement, as required by the Regulation (copy of the Statement attached to record minutes).

Members requested their thanks be passed to the Support Services Executive for her work in achieving such a high level of accessibility on the Council's website.
